03	The hard copies of filled in the application forms should be submitted to the OSBP by Hand/ Regd. Post / Speed Post on or before:	03.07.2024
04	Last date of deposit of examination fees (with or without fine) on or before:	03.07.2024

<sup>\*</sup>Keeping in view of examination urgency the portal will remain open for form fill-up of the students on 30·06.2024 (**Sunday**).

- ➤ Examination fees **Rs.1000/-** per candidate be deposited in O.S.B.P. account by RTGS / NEFT. The proof of deposit for all the candidates should be submitted along with filled in application forms for necessary verification by O.S.B.P. The amount may also be deposited in the form of Demand Draft in favour of Member Secretary O.S.B.P., Bhubaneswar.
- > Any application submitted with wrong candidature or examination fees deposited beyond the schedule date shall be rejected and any excess amount deposited for the purpose will be forfeited.
