INSTRUCTIONS TO CANDIDATES FOR APPEARING <u>THEORY EXAMINATION</u> (TO BE CIRCULATED BY THE PRINCIPAL/HOD OF THE AFFILIATED D.PHARM INSTITUTIONS)

- 1. At the time of taking delivery of the Admit Card, the candidate **must ensure** that it is his/her and also ensure that all **details**, **part and subjects** printed are correct.
- No change in Part or Subject will be allowed.
- 3. They must carry the Admit Card in color print duly signed by the Principal of their institution. The Admit Card will not be considered as valid without the signature of the Principal.
- 4. The Admit Card is issued subject to the candidate fulfilling the eligibility criteria of the examination.
- 5. It is obligatory for the candidate to retain this card and produce it before the concerned authority whenever required.
- 6. Candidates are advised to **verify the location of the examination centre** a day in advance so that they do not face any problem on the day of the examination.
- The candidate must report at the examination center by 09:00 AM i.e. one hour before commencement of exam.
- 8. Requests for change of examination centre will not be entertained.
- Friends, relatives, college staff accompanying the candidates will not be allowed inside the examination centre.
- 10. The examination timings are from 10:00 AM to 01:00 PM.
- 11. The candidates will be allowed inside the examination hall at 9:45 AM.
- 12. No candidate will be allowed entry inside the examination hall once the examination starts.
- 13. The candidates must be in college uniform and with ID card issued by the college.
- 14. The candidate should avoid putting on full shoes for appearing the examination.
- 15. They must carry the color print of the Registration card issued by OSBP, Bhubaneswar.
- 16. They must carry the original Aadhar Card with photograph as a valid identity proof for necessary verification.
- 17. Photocopies of ID even if attested/scanned photo of ID in mobile phone will not be considered as valid ID proof.
- 18. They must carry the College ID card.
- 19. At the entry point the following documents (in original) will be verified:
 - 1. Admit Card with signature of the Principal of the College
 - 2. Registration Card issued by OSBP, Bhubaneswar
 - 3. Aadhar Card with photograph as proof of ID
 - 4. College ID Card
- No candidate will be allowed inside the examination hall without proper frisking and the required valid documents.
- 21. Candidate must have and will be permitted to carry only the following items inside the examination hall Original Admit Card, OSBP Registration Card, valid ID proof/Aadhar Card, College ID Card.
- 22. One personal transparent water bottle, simple pen(s), pencil(s), simple geometry box are allowed inside the examination hall.
- 23. Candidates are NOT allowed to carry handbag, purse, any kind of paper/textual material (printed or written), Eatables (loose or packed), mobile phone/ear-phone/airpods/earpods/microphone, pager, calculator, DocuPen, pen drive, slide rules, camera, voice/video recorder, to wear/carry smart watch/electronic watch/calculator, any metallic item, electronic gadgets/ devices to the examination hall/room. Possession and/or use of any of the above items will lead to action as deemed proper as per rules.

- 24. Mobile phone, smart watch or any other electronic gadgets, communication device etc. are strictly prohibited. <u>Possession of any of the above</u> in the examination hall will be treated as Mal-practice.
- 25. Books, printed or written textual material, loose papers etc. are not allowed inside the examination hall.
- 26. Examination officials **will not be responsible** for safe keep of the belongings and there may be no facility for this at the centre.
- The candidate must legibly fill-in the following fields in the answer books failing which their result will be withheld.
 - a) Examination D.Pharm Supplementary Examination, 2024
 - b) Paper/Subject under E.R.1991 or E.R.2020
 - c) Subject -
 - d) Year and Part 2024, Supplementary and Part-I or Part-II
 - e) Roll No. All the 12 digits to be filled up
 - f) Regd. No. All the 11 digits to be filled up
 - g) Date of Examination -
 - h) Examination Centre -
- 28. No additional sheet will be provided to ER 2020 Syllabus candidates.
- 29. Candidates will write the answers in sequence on both sides of the answer sheet.
- 30. The candidate should not write anything other than answers in the answer books.
- 31. Answer books containing information other than the answers (e.g. mobile number/symbols not relevant to the answers/pleading/requests to evaluator etc.) will be treated as MAL-PRACTICE.
- 32. The answer books of SINGLE-SUBJECT MAL-PRACTICE (SMP) & MAL-PRACTICE (MP) cases will not be evaluated.
- 33. The candidate **should not adopt unfair means** or include in unfair examination practices, impersonation etc. Any candidates found using unfair means are liable for strict action as deemed proper as per rules.
- 34. If at any stage it is found the candidate has used unfair means, his/her candidature will be cancelled and action deemed proper will be taken.
- 35. The candidates should **avoid bio-breaks** during the first one hour after beginning of the examination and last half hour of the examination.
- 36. Candidates are not allowed to submit their answer books before an hour after the examination starts.
- 37. No candidate will be allowed re-entry once he/she has submitted the answer book.
- 38. Before leaving the examination hall for any purpose, the candidate must take permission of the invigilator and submit the answer book.
- 39. Candidates are not permitted to talk to each other inside the examination hall.
- 40. Candidate should not write anything on the question paper except his Roll No.
- 41. The candidate should not tear, disfigure, mutilate the answer book.
- 42. The candidates must follow the instructions/rules/guidelines for the examination.
