

1. **THE EXAMINATION FORM FILL-UP FOR THE CANDIDATES OF THE D.PHARM INSTITUTION WILL BE ALLOWED ONLY AFTER RECEIPT OF THE HARD COPY OF THE ELIGIBLE CANDIDATE LIST IN THE O/o OSBP, BHUBANESWAR WITHIN THE DUE DATE.**
2. **THE CANDIDATES WHOSE NAME ARE NOT SUBMITTED IN THE ELIGIBLE CANDIDATE LIST WILL NOT BE ABLE TO PARTICIPATE IN THE EXAMINATION FILL-UP THE FORM PROCESS.**
