The instructions regarding the entry/uploading of sessional marks (theory and practical) in the examination portal of OSBP, Bhubaneswar is as follows:

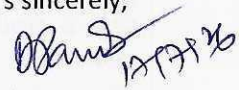
- THE CANDIDATES WHOSE SESSIONAL MARKS ARE NOT UPLOADED IN THE PORTAL WILL NOT BE ABLE TO FILL-UP THE ONLINE EXAMINATION FORM FOR D.PHARM SUPPLEMENTARY EXAMINATION 2025, PART-I & PART-II, ER 2020 SYLLABUS.** Hence, the Principal is required to ensure that the sessional marks of the candidate is **UPLOADED** within the scheduled date and time.
- Once the sessional marks are uploaded & submitted, **there will be no option to edit**. Hence, the Principal is required to be meticulous while uploading the sessional marks of the candidates as per the mark foil.
- The Principal is required to download the data-sheet of the sessional marks entered in the portal, verify the same and **submit the ink-signed hard copy** of the downloaded data-sheet in the O/o OSBP within the due date.
- The examination form fill-up of the institution/candidate will be processed only after receipt of the hard copy of item c. as above in the O/o OSBP, Bhubaneswar within the due date.

- e. THE SUBMISSION OF HARD COPY OF ANNEXURE-1/P-I/SM & ANNEXURE-2/P-II/SM (MARK FOIL) FOR ALL ELIGIBLE CANDIDATES IS MANDATORY FOR THE D.PHARM SUPPLEMENTARY EXAMINATION, 2025, PART-I & PART-II, ER 2020.
- f. There will be **no extension of date for submission of mark foil, hard copy and uploading of the sessional marks in the portal**. Any extension of date shall result in delay in the conduct of the examination leading to inconvenience to the students.
- g. OSBP will cross verify the sessional marks entered in the portal and the original mark foil submitted in the O/o OSBP. **In case of any mismatch between the mark foil (ANNEXURE-1/P-I/SM & ANNEXURE-2/P-II/SM) and the marks uploaded in the portal; the result of the candidate shall be WITH-HELD.**
- h. In case the sessional mark of a candidate is already uploaded and is available in the examination portal, the marks need not be uploaded again. To avoid any inconvenience to the candidates at a later stage, the Principal has to confirm that it is available in the Examination portal. However, in such cases the HARD COPY i.e. ANNEXURE-1/SM & ANNEXURE-2/SM is to be submitted in the O/o OSBP, Bhubaneswar within due time.

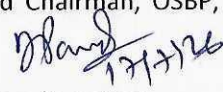

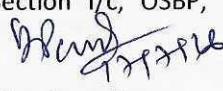

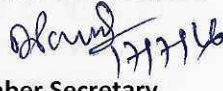
