The Principal of the affiliated colleges are requested to circulate the information regarding the examination to all the eligible D.Pharm students of their institution and ensure that the examination form is filled-up in an error-free manner within the due date and time.

The Principal is required to follow the following guidelines during the examination form fill-up process:

1. The examination form fill-up process will be in online mode only through the Examination Portal of OSBP, Bhubaneswar – www.osbp.in as per the schedule specified along with the fees.
2. After the scheduled date and time, applications will not be accepted.
3. THERE WILL BE NO EXTENSION OF DATE FOR EXAMINATION FORM FILL-UP.
4. No application in offline mode will be accepted.
5. All are required to adhere to the timelines and instructions.
6. Incomplete/offline/without-fee application will be summarily rejected.

7. The candidate whose name is included in the 'ELIGIBLE CANDIDATE LIST' submitted by the D.Pharm institution in response to **L.No.2258/OSBP/2026 dt. 15/07/2026** only are eligible to fill-up the online examination form. If it is found at a later stage that a candidate has filled-up the online examination form and his name is not included in the ELIGIBLE CANDIDATE LIST submitted by the institution, his candidature will be summarily rejected even if he has appeared the examination. The responsibility in such cases shall lie on the D.Pharm institution.
8. Only a **single application per candidate** will be accepted in the online process.
9. The candidate must **decide in advance** regarding the **Subject and theory or practical or both theory & practical** she/he wishes to appear in the examination and choose the subjects, theory or practical or both theory and practical accordingly at the time of online form fill-up itself. Once the subjects, subjects, theory or practical or both theory and practical are chosen and online form is filled-up, the subjects, theory or practical or both theory and practical **cannot be modified**.
10. If it is found that a candidate has submitted **multiple applications** or multiple times, all the applications submitted by him will be rejected.
11. The examination fee:

Part-I	Without fine	Rs.1000/- (Rupees one thousand only) per candidate per Part
Part-II	Without fine	Rs.1000/- (Rupees one thousand only) per candidate per Part
Part-I	With fine	Rs.1100/- (Rupees one thousand one hundred only) per candidate per Part
Part-II	With fine	Rs.1100/- (Rupees one thousand one hundred only) per candidate per Part

12. The fees are non-refundable and non-adjustable.
13. **Examination fees must be remitted to OSBP, Bhubaneswar before the last date of the online examination form fill-up.**
14. **The Principal should remit the examination fees of all the candidates of their institution preferably in a single online transaction (NEFT or RTGS).**
15. **After remitting the examination fees, the Principal shall submit the details in the format enclosed as ANNEXURE-1/EF.**
16. The fees can only be deposited online (**NEFT or RTGS only**) as per the details given below:

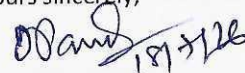
17. **Fees remitted in any other account shall not be considered.**

- c. Subject correction of candidates (if any) in **ANNEXURE – 2/ECW**
