D.Pharm Annual Examination, 2025, Part II, Theory (ER 2020 SYLLABUS)

INSTRUCTIONS TO CANDIDATES FOR APPEARING THEORY EXAMINATION (TO BE CIRCULATED BY THE PRINCIPAL/HOD OF THE AFFILIATED COLLEGES)

1. The candidate must reach the examination center by 09:00 AM i.e. one hour before commencement of exam.
2. Candidates are advised to **verify the location of the examination centre** a day in advance so that they do not face any problem on the day of the examination.
3. Request for change of examination centre will not be entertained.
4. The gate of the examination centre will be **opened one hour** before the commencement of examination.
5. The examination **timings are from 10:00 AM to 01:00 PM.**
6. The candidates will be **allowed** inside the examination hall at **9:45 AM.**
7. **NO CANDIDATE WILL BE ALLOWED ENTRY INSIDE THE EXAMINATION HALL ONCE THE EXAMINATION STARTS.**
8. The candidates should be in **college uniform and with ID card** issued by the college.
9. The candidate should avoid putting on full shoes for appearing the examination.
10. They must carry the **ORIGINAL ADMIT CARD in color print duly signed by the Principal of their institution to the Examination Centre.**
11. **The Admit Card will not be considered as valid without the signature with date and office seal of the Principal.**
12. **The ADMIT CARD SHOULD NOT BE LAMINATED TILL THE COMPLETION OF THE EXAMINATION.**
13. **The candidate shall put his/her signature in the designated place in the Admit Card in front of the invigilator on the first day of the examination.**
14. The candidate must carry his/her original admit to the examination centre on **all the days of the examination.**
15. At the time of taking delivery of the Admit Card from the Principal of their D.Pharm institution, the candidate **must ensure** that it is his/her and also ensure that all **details and subjects** printed are correct.
16. The Admit Card is issued **subject to** the candidate fulfilling the eligibility criteria of the examination.
17. It is obligatory for the candidate to retain the original admit card and produce it before the concerned authority whenever required.
18. The candidate must carry his/her original Registration card issued by Odisha State Board of Pharmacy, Bhubaneswar in color print to the Examination Centre during all the days of the examination.
19. The candidate must carry his/her original Aadhaar Card with photograph as a valid identity proof for necessary verification to the Examination Centre on all the days of the examination.
20. The candidate must carry his/her original College ID card to the Examination Centre during all the days of the examination.
21. At the **entry point** the following documents (**in original**) will be verified **on all the days of the examination**:
 1. **Admit Card (color print) with signature of the Principal of the College**
 2. **Registration Card issued by OSBP, Bhubaneswar**
 3. **Aadhaar Card with photograph as proof of ID**

22. No candidate will be allowed inside the examination hall without proper frisking and without the required valid documents as mentioned above.
23. The candidate must legibly fill-in the following fields in the answer books failing which their result will be withheld.

24. No additional sheet will be provided to the candidates.
25. The candidates has to write the answers in sequence on both sides of the answer sheet except the first cover page.
26. The candidate is required to follow the instructions given in the first page of the answer book meticulously.
27. **MOBILE PHONE, SMART WATCH, ANY OTHER ELECTRONIC GADGET, ANY COMMUNICATION DEVICE ETC. ARE STRICTLY PROHIBITED INSIDE THE EXAMINATION HALL. POSSESSION OF ANY OF THE ABOVE IN THE EXAMINATION HALL WILL BE TREATED AS MAL-PRACTICE EVEN IF IT IS NOT USED.**
28. Books, printed or written textual material, loose papers etc. are not allowed inside the examination hall.
29. The candidate should not write anything other than answers in the answer books.
30. **Answer books containing information other than the answers (e.g. mobile number/symbols not relevant to the answers/pleading/requests to evaluator etc.) will be treated as MAL-PRACTICE.**
31. The answer books of SINGLE-SUBJECT MAL-PRACTICE (SMP) & MAL-PRACTICE cases will not be evaluated.
32. Any Unfair Means by the candidate will be penalized as per the Unfair Means Guidelines of OSBP, Bhubaneswar.
33. The candidates must follow the instructions/rules/guidelines for the examination.
34. The candidates must cooperate with the observer/supervisor/central squad/invigilators/center superintendent for any type of search in the examination center.
